- The data will be used exclusively for the purposes described in the data protection statement. Any other use will always be subject to further consent. Your data will not be used for advertising purposes.
- GIZ and designated third parties (for details, see below) have implemented appropriate technical and organisational measures to protect data against unintended or deliberate falsification, destruction, loss or access by unauthorised persons. Access to your personal data is restricted to GIZ staff (Bonn office, division G110, Hospital Partnerships – Partners Strengthen Health global programme) and the relevant designated third parties who need to process it for the above-mentioned purpose(s), and who will handle the information you provide in a proper and confidential manner.
- Your data are shared solely with the third parties designated below. Your data may be shared with other third parties for the above-mentioned purposes only subject to your further consent.

Rights of the data subject
